

The Thrive Wealth Management (“Thrive”) Rider Platinum Ticket Giveaway (“the Contest”) sponsored by Conexus Credit Union (“Conexus”) is intended to be conducted in Saskatchewan only and shall be construed according to Saskatchewan law. Entry into this contest constitutes acceptance of these Contest Rules (the “Contest Rules”).

The prize (“Prize”) refers to 4. Prizes and Prize Terms

“Social Media Platforms” include Instagram and Facebook.

1. ELIGIBILITY

This Contest is open for and intended as giveaway for Saskatchewan residents. Contestants must be an Individual with a valid personal Instagram account and/or personal Facebook account. Corporate business accounts are unable to participate in the contest. Sole proprietary business accounts are eligible to participate in the contest with the winner being the sole proprietor and owner of the business account. Please see below for information on how to enter.

Individuals are not required to be a member of Conexus or a client of Thrive.

There is no purchase necessary to enter the Contest.

Only individuals above the age of 18 are eligible to participate in the Contest.

Employees, directors and officials of Conexus and its subsidiaries and their immediate families or individuals of the same household including common law spouses (“Conexus Representatives”) are not eligible to win a prize in the Contest.

All contest entries must be received before the end of the Contest Period (between the Start Date and the Closing Date). Conexus assumes no responsibility and will not be liable for entries that are not received before the end of the Contest or entries that are incomplete, lost, misdirected, illegible or otherwise irregular for whatever reason, including, without limitation, due to branch hours, branch closures or other events outside of Conexus’ reasonable control.

Conexus’ computer system will be the official time-keeping device for the Contest.

All entries become the sole property of Conexus, and none will be returned for any reason.

If a Prize Winner cannot be contacted by Monday, August 16, 2021 at 8:00 a.m. Central Standard Time (CST) his/her/their entry will be disqualified. Another Prize Winner will then be selected from the remaining eligible entries and will be given 24hrs to accept the Prize before being disqualified. The process above will be repeated every morning at 8:00 a.m. Central Standard Time (CST) until such time as contact is made with a Prize Winner, or until the game day on Friday, August 21, 2021, or until there are no more eligible entries.
